Following the Call to Order by Mayor Cantrell, Council Member Bartley made the motion to accept the July 7, 2020 Council Meeting Minutes as submitted in writing by the Clerk. Council Member Rankin seconded the motion, and all were in favor.

## **NEW BUSINESS**

NATHAN LENTS - ZONING VARIANCES REQUEST.....

## **BUSINESS FROM THE FLOOR**

Joey Torres, Eton taxpayer, asked the Mayor and Council why the Eton Fire Department was now closed on the weekends and if the Mayor thought fireworks were more important than the safety of Eton citizens. The Mayor stated for budgetary reasons, it was necessary to temporarily furlough Eton's part-time firemen on the weekends, however, Murray County was covering all Eton calls during the weekends and the safety of Eton citizens is not at risk. He stated this furlough will be reviewed every 30 days and the weekend hours will be restored when the budget permits. Mr. Torres also made the comment that the Mayor has been trying to get rid of the Eton Fire Department for years and Commissioner Hogan had confirmed as such. The Mayor stated this is absolutely untrue and he has had no intentions of doing away with the Eton Fire Department.

### **EXECUTIVE SESSION**

Council Member Dooley made the motion to enter Executive Session to discuss personnel matters. Council Member Bartley seconded the motion, and all were in favor.

Council Member Dooley made the motion to adjourn Executive Session and reconvene regular Council Meeting. Council Member Bartley seconded, and all were in favor. No action taken during Executive Session.
